
## SHOULD YOU LET US KNOW IF YOU DECIDE TO LEAVE A LEGACY TO THE MUSEUM?

## WHAT SHOULD YOU CONSIDER BEFORE LEAVING A LEGACY GIFT?

If you are thinking of leaving a legacy gift, you will be reflecting on the special place the Museum holds in your life. You may have valued a particular role at the Museum, enjoyed memorable visits with your family, friends, children (and grandchildren) or have a sincere commitment to the cultural life and to learning in our town and surrounding area.

The process of writing or amending you need not be complicated but we do recommend you consult a solicitor who can advise on a number of matters including how a legacy can reduce inheritance tax. If you already have a Will, a solicitor can explain about making a small change known as a codicil.

Before making a decision, you need to think whether to leave a gift of a fixed sum or, instead, to leave a percentage of your estate. Some people prefer offering a restricted gift (i.e. where you specify what it should be used for) while others prefer an unrestricted gift (which can be used to support the Museum's greatest needs).
